GENERAL TERMS

- Rates are quoted and payable only in US\$
- Rates are subject to availability of Rooms

CHILDREN

- Child 3 -12 years (sharing with 01 fully paid adult)
- Child 3 12 years (sharing with 2 fully paid adults)
- Children 3 12 years (occupying own room)
- Not more than one child of below 12 years will be allowed to share the room with 2 fully paid adults.
- No Triple rooms are allowed.
- Children Policy does not apply in case of Easter, Christmas & New Year Supplements and Extra Meals & Extra Lunch Boxes. Children pay
 the same as adults in-case of seasonal surcharges and extra meals and lunch boxes

CONCESSION FEES
