CANCELLATION POLICY:

Any confirmed booking that is cancelled, reduced in length of stay, or in number of guests is treated as cancellation under the following conditions:

- A: Between 60 days and 45 days before arrival will be charged 50% of full amount to be paid as cancellation fee.
- B: Between 45 days and 15 days before arrival will be charged 75 % of full amount to be paid as cancellation fee.
- C: Any day less than 15 days before arrival and all no-shows will be charged 100% of full amount.
