If you require more time to confirm the booking, the expiry date may be extended upon request (subject to availability). Provisional bookings will be held according to the following policy:

- 10 days for bookings received more than 4 months prior to arrival
- 5 days for bookings received less than 4 months prior to arrival
- Last minute bookings are held until another inquiry is received. At which point we reserve the right to release the booking if full payment is not forthcoming.
