(1) Hemingways Hospitality Limited, a private company incorporated under the laws of Kenya with company registration Number CPR/2009/7855 and whose registered address is at Hemingways House, Karen Office Park, P.O.Box 146-00502, Nairobi, Kenya (hereinafter referred to as the Hotel which expression shall where the context so admits include the Hotel's successors in title and permitted assigns); and

Each a **Party** and together the **Parties** 

# **1 GENERAL TERMS**

1.1 Contract rates and offers for each of Hemingways Nairobi Limited, Ol Seki Limited and Hemingways Watamu Limited are set out in Appendices 1, 2 and 3 respectively.

1.2 The Term of this Agreement shall be from 01st January 2021 to 3<sup>rd</sup> January 2022.

1.3 All rates quoted in this Agreement apply to all booking types. Rates are quoted in United Stated Dollars, include all local taxes and service charges and are net non commissionable.

1.4 Reservation requests must be sent directly to the Reservations Department, and will ONLY be considered to be confirmed upon receipt of the requisite deposit and/or payment or a valid booking voucher from those Agencies with approved credit facilities in accordance with Clause 3.4, 3.5 and 3.6.

1.5 The Hotel reserves the right to stop selling Foreign Independent Traveller (FIT), Group and Tour Series allocations at any given time. An option will be given to the Agency to confirm the existing allocation, if any, within a timeframe determined by the individual hotel within which the Agency can guarantee the allocation with a pre-payment.

#### 2 CANCELLATION, NO SHOW & AMENDMENT

2.1 All reservations, cancellations and/or amendments must be made in writing to the Reservations Department.

2.2 The Hotel reserves the right to accept name changes for individual travelers, travelers within tour groups as well as tour group name changes.

2.3 Cancellation fees covered by this Agreement apply as per the below cancellation deadlines.

2.3.1 More than 60 days prior to the arrival date, 20% charge applies on the entire booking value

 $2.3.2\ 60-30$  days prior to the arrival date, 45% charge applies on the entire booking value

 $2.3.3\ 29-21$  days prior to the arrival date, 55% charge applies on the entire booking value

 $2.3.4\ 20 - 14$  days prior to the arrival date, 75% charge applies on the entire booking value

2.3.5 13 days or less prior to the arrival date and no shows, 100% charge applies on the entire booking value

2.4 For the Premium and High Season at Ol Seki Hemingways Mara, 100% cancellation fee applies for any cancellation or amendment made within 90 days of the arrival date.

2.5 For the Premium Season at Hemingways Watamu and Hemingways Nairobi, 100% cancellation fee applies for any cancellation or amendment made within 60 days of the arrival date.

2.6 Reservations will only be held tentatively for a maximum of seven (7) calendar days. Thereafter the Hotel will automatically release all tentative reservations which have not been confirmed by receipt of the required deposit or a valid booking voucher from those Agencies with approved credit facilities.

2.7 In addition to the above, amendments to reservations that fall within the given cancellation period will be treated as a cancellation and cancellation fees will apply in accordance with the cancellation policies set out in Clause 2.3. This applies to changes in initial arrival dates as well. Amendments



that involve changes other than accommodation (e.g meal plan) will be permitted as usual without cancellation fees.

2.8 For the avoidance of doubt, the making of a reservation at the rates set out in this Agreement will be considered as acceptance of the terms and conditions of this Agreement, regardless of whether the Agency has signed the Agreement.

# **3 PAYMENT AND CREDIT FACILITIES**

3.1 Payment must be made in the invoiced currency by Real Time Gross Settlement (RTGS) bank transfer for same day value and be made net of any transaction charges incurred.

3.2 Subject to clause 3.5 and 3.6 all reservations are payable fully in advance at least 60 days prior to the arrival date, unless credit facilities have been applied for and approved in writing by the Hotel.

3.3 A deposit paid in respect of any reservation made pursuant to the terms of this Agreement is specific to that reservation and may not be transferred to any other reservation unless agreed by the Hotel in writing.

3.4 A non-refundable 20% deposit must be made upon booking in order to confirm and guarantee the reservation unless the Agency has an approved credit facility in which case a valid booking voucher must be issued to confirm a reservation.

3.5 For bookings for Ol Seki Hemingways Mara, 100% of the booking value is required to be paid at least **30** days prior to the arrival date.

3.6 For bookings for the Premium Season at Hemingways Watamu, 100% of the booking value is required to be paid at least **60** days prior to the arrival date. For Agencies with approved credit facilities a valid booking voucher must be issued to confirm a reservation.

3.7 Except for any deposit paid, any advance payments made are refundable in line with the cancellation policies.

3.8 Credit facilities can be applied for through the Accounts Department of the Hotel and are subject to the following conditions:

- The Agency must supply bank references
- Invoices for credit facility accounts are payable within 30 days of the invoice date and should be settled by Real Time Gross Settlement (RTGS) bank transfer for same day value.
- If the Agency does not pay any undisputed invoice (or part thereof) submitted by the individual hotel within 30 days of the invoice date, the Agency shall pay interest on the outstanding amount of the invoice at the rate of two per cent (5%) per month and the Hotel will be entitled

at its sole discretion to refuse acceptance of any future vouchers/ reservations from the Agency.

• Any delay in payment may result in suspension or withdrawal of credit facilities by the Hotel.

#### 4. DISPUTES

4.1 Any dispute regarding an invoice, or part of an invoice, must be delivered in writing to the Hotel's Accounts Department within 14 days of the invoice date and only the amount in dispute may be deducted from the invoice and payment due, which must be made within the specified time limit.

#### **5. TOUR GUIDES RATES**

5.1 For any group of 15 paying guests (the 'Group'), the Hotel will offer 1 complimentary half twin bedroom free of charge. The complimentary bedroom shall be occupied by an accompanying tour guide of the Group only and is available for the same duration as the Group booking. This offer is subject to room availability. The complimentary half twin will be offered on a bed and breakfast basis for Nairobi and Watamu and full board for Hemingways Ol Seki Mara. Conservancy fees for the tour guide will remain payable.

#### **6 OTHER TERMS AND CONDITIONS**

6.1 To avoid communication and distribution related disputes, the Agency is required to share their list of distribution partners with the Hotel regularly or at the request of the Hotel.

6.2 Unless otherwise agreed in writing by the Hotel, the check-in time is 1300hrs and check out time is 1000hrs.

6.3 The Agency, with its distribution partners, is required to ensure those guests arriving through them are covered by a fully comprehensive travel insurance policy including medical evacuation cover.

#### 7 VALIDITY

7.1 This Agreement and the rates contained herein will only be honored by the Hotel upon receipt of a counter signed copy from the Agency within 14 days.

#### **8 TERMINATION**

8.1 The Hotel reserves the right to terminate this Agreement with immediate effect at any time, without prejudice to any other rights it may have, in the event that the Agency fails to comply with the terms of this Agreement.

8.2 The Hotel reserves the right to terminate this Agreement at any time upon 60 days' notice to the Agency, without prejudice to any other rights it may have.

8.3 Termination of this Agreement by the Hotel shall be effected by written notification to the Agency of such



termination in accordance with the Notice provisions of this Agreement.

# 9 TAX AND OTHER CHANGES

9.1 The Hotel reserves the right to change the rates in case of changes in applicable government taxes, fees or assessments as well as any changes in applicable labor laws, service charges or conservancy fees.

# **10 CONFIDENTIALITY**

10.1 Each Party undertakes that it shall not at any time during the Term, and for a period of two (2) years after the termination of this Agreement, disclose to any person any information concerning the business, affairs, customers, clients or suppliers of the other Party except as permitted by this Clause 10.

10.2 Each Party may disclose the other Party's information:

10.2.1 to its employees, officers, Representatives or advisers who need to know such information for the purposes of exercising the party's rights or carrying out its obligations under or in connection with this Agreement; and

10.2.2 as may be required by law, a court of competent jurisdiction or any governmental or regulatory authority.

10.3 The information set out in Clause 10.2 shall only be used to as necessary for the performance of obligations under this Agreement.

# 11 WAIVER

11.1 A partial failure or delay by the Hotel to enforce at any time any of the provisions of this Agreement, or to exercise any option or right which is hereby provided, or to require at any time performance of the provision hereof, shall in no way be construed as a waiver of, nor preclude the exercise of, any of the provisions of this Agreement nor affect the validity of the Agreement nor prejudice the Hotel as regards to subsequent action.

# **12 FORCE MAJEURE**

12.1 Neither party is liable for delay or failure to perform any of its obligations under this Agreement in so far as the performance of such obligation is prevented by a force majeure event.

12.2 Each Party shall notify the other Party of the occurrence of such Force Majeure Event and shall use all reasonable endeavors to continue to perform its obligations hereunder for the duration of such Force Majeure Event. However, if any such Force Majeure Event prevents a Party from performing all its obligations hereunder for more than one (1) month, the other Party may terminate this Agreement by notice in writing.

12.3 For the purposes of this Agreement, a Force Majeure Event means any circumstance not within a Party's reasonable control including, without limitation:

12.3.1 acts of God, flood, drought, earthquake or other natural disaster;

12.3.2 epidemic or pandemic;

12.3.3 terrorist attack, civil war, civil commotion or riots, war, threat of or preparation for war, armed conflict, imposition of sanctions, embargo, or breaking off of diplomatic relations;

12.3.4 nuclear, chemical or biological contamination or sonic boom;

12.3.5 any law or any action taken by a government or public authority, including without limitation imposing an export or import restriction, quota or prohibition;

12.3.6 collapse of buildings, fire, explosion or accident; and

12.3.7 interruption or failure of utility service;

# **13 ASSIGNMENT**

13.1 Except for an assignment to any parent corporation, subsidiary or successors-in-interest to either Party (excluding competitors of the other Party), neither Party may assign any rights, duties, obligations or privileges under this Agreement without the written consent of the other Party provided that such consent shall not be unreasonably withheld.

# 14 ENTIRE AGREEMENT AND VARIATION OF AGREEMENT

14.1 This Agreement constitutes the entire agreement between the parties and supersedes any and all prior agreements or representations, whether oral or written, pertaining to the

14.2 Content hereof and may not be amended except by a written document signed by all parties. No modification, amendment, supplement to or waiver of this Agreement or any of its provisions shall be binding upon any party unless made in writing and signed by all parties. The parties agree that for purposes of this Agreement and any amendment or



modification thereto, or for any other notice or communication between the parties, signatures sent or received by facsimile transmission will be considered as enforceable and valid as original signature by the party signing.

#### **15 REPRESENTATION AND WARRANTIES**

15.1 Both Parties represent and warrant that they have full authority to execute, deliver and perform this Agreement on behalf of the party for which they sign.

# **16 NOTICES**

16.1 Any notice required to be given hereunder shall be in writing and shall be delivered by hand.

# 17 GOVERNING LAW

17.1 This Agreement shall be governed by and construed in accordance with the laws of Kenya.

# 18 ARBITRATION

18.1 Each Party shall use all reasonable endeavours to settle amicably any dispute arising out of or in connection with this Agreement or in its validity, interpretation or termination.

18.2 Save as herein otherwise specifically provided, any dispute (including as to the interpretation validity enforceability or termination of this Agreement) between the Parties as to matters arising under or pursuant to this Agreement as aforesaid which cannot be settled amicably within fifteen (15) days after receipt by one Party of the other Party's request for such amicable settlement may be submitted by either Party to arbitration in accordance with the provisions of Clauses 0 to 0 (both inclusive).

18.3 If the Parties so agree, the dispute shall be referred to a single arbitrator or if they are unable to agree upon the person to be appointed as arbitrator within ten (10) days

from the date of the notice requesting arbitration, the arbitrator shall, at the request of either Party, be appointed by the Chairman of the Chartered Institute of Arbitrators of the United Kingdom, Kenya Branch or failing him by the President of the Law Society of Kenya. The venue and seat of the arbitration shall be Nairobi.

18.4 Arbitration proceedings shall be conducted in accordance with the rules or procedures for arbitration of the Chartered Institute of Arbitrators of the United Kingdom, Kenya Branch.

18.5 If for any reason an arbitrator is unable to perform his function, a substitute shall be appointed in the same manner as the original arbitrator.

18.6 The decision of the arbitrator shall be final and binding on the Parties.

18.7 The fees and expenses of the arbitrator shall be borne by the Parties in equal shares.

18.8 Notwithstanding the above provisions of this Clause 18, a Party is entitled to seek preliminary injunctive relief or interim or conservatory measures from any court of competent jurisdiction pending the final decision or award of the arbitrators.
